Dear folks,

Kindly allow me to take this opportunity to introduce to you our Company, Flora Cereals (U) Limited. Flora Cereals (U) Limited was fully incorporated in Uganda on January 14th, 2014 (after a restructuring business process). However, the company was formerly being operated as a Sole Proprietorship (family owned business), with initial business operations having started in early 1994 in rice and maize milling; giving us a close to 20 years business experience in the field of agro processing and procurement. All our major business operations ever since our founding have been based in Busowa Trading Center, in Bugiri District (Formerly Iganga District).

Recently, our Directors and Board membership passed a resolution to have the Company undertake a close to US\$2, 500,000.00 (Two million and five hundred thousand dollars) business expansion (with funding expected to be from loans and grants) in the next 5-10 years. The business expansion is expected to;

- a. Involve upgrading of our current rice and maize mills (purchase and installation) to increase the current production to about 15 to 20 tons per day with 24-7 operations for each mill.
- b. Acquisition of new land to permit the expansion of the intended project.
- c. Construction of storage silos/warehouse for the procured produce from farmers and the processed products; grain, flours and other foods.
- d. Create an avenue through which local farmers can be partners; with stock in the company; preferably through a legally formed non-partisan and non-discriminatory Farmers' Association or Group.
- e. Have the company venture into selling high quality agro processed products on both the local and international markets.
- f. Be a procurement vendor and supplier of agro-produce and processed products to both locally based and internationally based agencies.

We anticipate that the business project will;

- a. Create a revenue support (.i.e. local taxes) for the local government and other local businesses.
- b. Provide local farmers with competitive rates for their procured agro-produce.
- c. Be an employment opportunity for the local community members in the area where it is to be established; from the construction until its perpetual life of the Company operations. The job estimates are close to 30-50 for construction jobs and 50-80 agro-processing jobs (e.g. millers, packers, sorters, laborers, drivers among others) in the initial operations, and with future expansion, we anticipate to employ an additional 100-120 individuals; mainly as rice and maize out-growers. Our policy is to employ locally based individuals.
- d. We also expect that this will put an economic development mark in the area, increasing its chances of attracting more business(es).
- e. Our future projects will also involve creating funding opportunities (.i.e. low interest based loans and grants) for the local farmers in the area of operation.
- f. With our technical advisory team of scientists in the Agricultural sector, we anticipate that the local farmers will directly benefit from their advisory services too, at no cost to the local farmers.
